Preamble:

In Govt. Order Dated: 17-09-94 read (1) above, Govt. have formulated reservation policy for Schedule Casts and Scheduled Tribes and other Backward Classes for admissions to professional courses for the year 1994-95 as per the lists of castes enclosed thereto as follows:

CATEGORY-I	4%
CATEGORY-II (A)	15%
CATEGORY-II (B)	4%
CATEGORY-III (A)	4%
CATEGORY-III (B)	5%
SCHEDULED CASTES	15%
SCHEDULED TRIBES	3%

- Under the said order Dated: 17-09-94 it has also been stated that no person other than belonging to Scheduled Castes, Scheduled Tribes and Category-I of Backward Classes shall be entitled to the benefit of reservation for admission to professional courses unless he/she satisfies the conditions of the creamy layer specified there under.
- In G.O. Dated: 31-01-1995 read at Sl. No. 2 above, the aforesaid reservation and creamy layer policy envisaged in the order Dated: 17-09-94 read at Sl. No. (1), has been made applicable to the employment too, under Article 16(4) of the Constitution of India.
- In G.O. Dated: 14-02-96 read at Sl. No. (3) above the Creamy Layer Policy existed as on 01-01-95 for the purpose of admission to the professional courses was also made applicable to employment with retrospective effect from 01-01-94.
- In Writ Petition No. 438/94 the Hon'ble Supreme Court of India have passed an interim order stating that the reservation in any case should not exceed 50%. Similar writs bearing No. 417/94, and 694/94 are pending disposal before the Hon'ble Supreme Court. Therefore, in G.O. No. SWD 61 BCA 95 Dated: 28-12-95 the currency of the 50% reservation specified in G.O. Dated: 17-09-94 and 13-01-95 has been extended till the final decision in WP No. 438/94, 471/94 and 694/94 is taken by Hon'ble Supreme Court.
- Now the Karnataka State Commission for Backward Classes have submitted special report and 71 advices vide their letter Dated: 04-12-2000 read at Sl. No. 4 above. Pending consideration of the entire report, the Government have examined in detail the Creamy Layer Policy contained in the Special Report and 71 Advices relating to inclusions, deletions, correction of spellings etc. and have made the following orders:

CONSENSUAL AGREEMENT

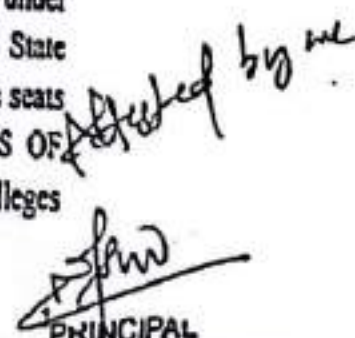
CONSENSUAL AGREEMENT BETWEEN GOVERNMENT OF KARNATAKA AND PRIVATE PHARMACY COLLEGES OF KARNATAKA IN THE MATTER OF REGULATING ADMISSIONS AND FEE STRUCTURE FOR THE DIPLOMA, UNDER GRADUATE, POST GRADUATE AND PHARM.D. COURSES IN PHARMACY IN PRIVATE PHARMACY COLLEGES OF KARNATAKA FOR THE ACADEMIC YEAR 2018-19 AND 2019-20.

I. PREAMBLE:

"The Karnataka Professional Educational Institutions (Regulation of Admission and Determination of Fee) Act, 2006" (Karnataka Act No. 8 of 2006) as amended by Act No. 39 of 2015 and Act No. 22/2017, enables the State Government to enter in to consensual arrangement with private professional colleges, regulating seat sharing, admission process and fee structure, and in furtherance thereof, after due deliberations and negotiations, consensus having been arrived at, and taking note of changes circumstances in the mean time, having reiterated the consensus in terms hereunder stated, this agreement is being entered in to, between Government of Karnataka AND PRIVATE PHARMACY COLLEGES OF KARNATAKA in the state.

In the light of the pronouncement of the Hon'ble supreme Court in TMA Pai Foundation case [(2002) 8 SCC 481], it is permissible for the managements of Private Unaided Professional Colleges and the State Governments to enter into consensual agreements, with respect to seat sharing, admission process and determination of fee structure arrangements.

The surrender of the seats by PRIVATE PHARMACY COLLEGES OF KARNATAKA to the State Government would take care of implementation of the Reservation policies of the State Government, namely, reservation of seats under Article 371J as well as Article 15(5) of the constitution of India. The State Government shall implement the above referred reservation policy from the seats surrendered by the members of the PRIVATE PHARMACY COLLEGES OF KARNATAKA to the State Government. In so far as Private Pharmacy Colleges located in Hyderabad-Karnataka region, Article 371J shall be implemented.

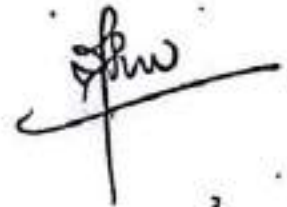

2. GENERAL:

- a) The parties herein are entering into this consensual agreement, in terms of the Act No. 8/2006 as amended by Act No. 39 of 2015 & Act No. 22/2017. The Karnataka Professional Educational Institutions (Regulation of Admission and Determination of Fee) Act, 2006 empowers the State Government to enter into consensual agreement with PRIVATE PHARMACY COLLEGES OF KARNATAKA. This agreement is valid for the academic year 2018-19 and 2019-20.
- b) That it is agreed between the parties that, the regulatory authorities, including Board of Examination Authority (BEA) /Rajeev Gandhi University of Health Science (RGUHS) /Karnataka Examination Authority (KEA) etc. shall be associated in working out this consensual arrangement and State Government would issue appropriate directions/make appropriate requests, as a policy of the government and, ensure that such authorities recognize and agree to working of this agreement, for the purpose of approval of admissions, levy to tuition fees etc. in accordance with terms of this agreement.
- c) The Government seats in Private Pharmacy Colleges shall be allotted by the Karnataka Examination Authority (KEA) and the management seats in Private Pharmacy Colleges shall be allotted by the concerned colleges.

3. SEAT SHARING:

- a. The member institutions of PRIVATE PHARMACY COLLEGES OF KARNATAKA, imparting studies in DIPLOMA, UNDER GRADUATE, POST GRADUATE AND PHARM.D. COURSES in their respective Institutions, shall handover /make available the below mentioned percentage of seats out of the total intake available in each course in each their member Pharmacy College to the Government for allotment through Karnataka Examination Authority (KEA).

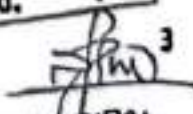

The counseling and allocation of the above seats shall be on the basis of inter-se merit determined under the Entrance examination with subsidized fee as agreed in this agreement.

3. The Government quota seats in each course in Private Pharmacy Colleges shall be filled by the Government based on merit. The following is the criteria for determination of Merit/Rank.

The remaining seats with Private Colleges would be filled from any other eligible candidates has prescribed by the appellate bodies.

4. FEE STRUCTURE:

- The Government of Karnataka exempts the members of DIPLOMA, UNDER GRADUATE, POST GRADUATE AND PHARM.D COURSES Educational institutions from the provisions of section 7 (2) of the Karnataka Professional institutions (Regulation of Admission and Determination of Fee) Act, (Karnataka Act No. 8 of 2006) in respect of Fee for Government seats in Private Colleges and in lieu thereof the following fee structure shall be agreed and adhered to.

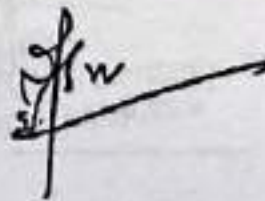
b. The Pharmacy Colleges; considering the request by the state Government, have now resolved to extend the same gestures as were extended for earlier year, by way of scholarship to socially and economically weaker sections and others; and participate in social welfare measures/schemes of the Government. Therefore, it is proposed and provided that, for all pharmacy course seats made over to the Government for grant of admission in accordance with its reservation policy, the members of Pharmacy colleges will extend the free ships and scholarships by way of fee concessions from the fees actually being charged by each of the Private pharmacy institutions for the current year; by way of scholarships under this consensual arrangement; out of fees receivable from the category of students falling under NRI and Management quota. The fee Matrix indicating the actual tuition fee that would be levied for the Pharmacy courses in respect of Govt. seats in Private Pharmacy Institutions, under allocations by KEA/concerned colleges for 2018-19 shall be as per table above.

c. KEA allotted candidates for Courses would pay the fees at the time of allotment of seats; and on seeking admission under the allotment as may be prescribed and notified. The KEA shall inform the students prior to the admissions that the admission is subject to payment of fees as published by the Karnataka Examination Authority. Fee structure shall be binding on all the students admitted by the respective colleges. KEA allotted students shall pay fees in the manner prescribed below:

1. With respect to choice "I" students- the KEA to direct the students to obtain the D.D in favour of respective institution opted by them as 1st choice.
2. For other choices- The fees is paid by students to KEA; the KEA shall send the fee within a fortnight from the date of issuance of allotment letter to respective institutions.

5. MODALITIES OF ADMISSION:

- a) A 'seat matrix shall be drawn in consultation with respective institutions and notified in terms of seat matrix order issued by the Government.



- b) In view of the making over of percentage of seats agreed of its total available seats in Pharmacy courses, the Government of Karnataka, hereby exempts the members of the Private Pharmacy colleges from the obligation, if any, if providing for reservations for either SCs, STs, or Other backward classes separately, since the Government of Karnataka itself in providing for requisite 'reservations' in seats now available to the Government out of aforesaid agreed percentage of seats in Pharmacy Courses in the institutions/colleges of private managements as required under Article 15 (5) of the constitution which enables the State Government to make special provisions for Schedule caste or Schedule Tribes in private educational institutions. The Private Institutions also need not make separate reservations under Article 371J of the constitution of India, which provides for reservation for people from Hyderabad-Karnataka region, except in respect of institutions located in the said region.
- c) It is stipulated that the counseling by the KEA shall be conducted as per the calendar of events, prescribed by the regulating authorities namely the AICTE and affiliating University respectively. In the event of a conflict/ variation in calendar of events published, the calendar of events mandated by the apex bodies; or Orders of the courts would prevail and apply.
- d) All member professional colleges shall grant admissions on receipt of allotment letters issued by the KEA; and on receipt of allotment letters along with demand drafts issued in favor of the college from the student and documents pertaining to qualifications etc. The details of the fee inclusive of all components shall be furnished to the State Government in advance so that the same can be informed to the students prior to the date of counseling. Once the admission has been done, the KEA cannot cancel the seats after the last date of counseling without the prior consent of the respective colleges.
- e) Any grievances, in the matter of counseling/admissions made by KEA will be redressed by the authorities of the monitoring committee under the chairmanship of Principal Government College of Pharmacy, Bengaluru strictly in terms, and within the scope of this agreement.

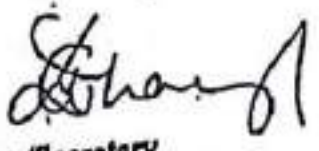
f) A copy of the admissions, if any, made by the private colleges in respect of unfilled seats on each day shall be forwarded to the admission overseeing committee and any grievances raised by the student so admitted shall be redressed by the said committee, which shall keeping in view the terms of the agreement; shall make such orders as are necessary and same shall be binding on respective institutions, if the grievances are as to the admission process by the member institution, before any directions are issued by the said committee.

g) To prevent any dispute or litigation in the matter of consensual arrangement now being entered in to between the State Government and the Private Pharmacy Colleges of Karnataka, relating to either Seat Sharing Formula and/or Fee Structure for the batch of students being admitted through KEA or any other issues connected there with it, the decision of the Admission Overseeing Committee headed by a retired High Court Judge shall be final with regard to admission process.

h) The Government would ensure implementation of this consensual arrangement as per the Karnataka Professional Educational Institutions (Regulation of Admission and Determination of Fee) Act, 2006 as amended by Act No. 39/2015 & Act No. 22/2017 and facilitate working out this consensual arrangement. Notwithstanding the delay in steps being taken as above; this consensual arrangement binds all the governmental authorities, including the students that may be admitted in terms of this agreement for the academic year 2018-19 and 2019-20 and Government shall ensure the implementation thereof.

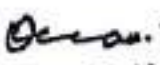

Proposal:

The Registrar Rajiv Gandhi University of Health Sciences 4th 'T' Block, Jaynagar, Bangalore in the letter read above has sent a proposal with recommendation to start new course in Pharm D with an intake of 30 seats and Pharm D (PB) with an intake of 10 seats admission during academic year 2012-13 subject to a condition that R R College of Pharmacy should obtain the permission from Pharmacy Council of India, New Delhi.

In the above read letter the Registrar, Rajiv Gandhi University of Health Sciences, Bangalore has sent a proposal with recommendation to the Government to start new course in Pharm D with an intake of 30 seats and Pharm D (PB) with an intake of 10 seats in R R College of Pharmacy during the academic year 2012-13, subject to condition that the college as per decision taken in the University Academic Council and syndicate.

After verifying the proposal sent by Rajiv Gandhi University of Health Sciences, the Government has decided to permit R R College of Pharmacy to start Pharm D with an intake of 30 seats and Pharm D (PB) with an intake of 10 seats admission during the academic year 2012-13. Hence this below mentioned order.

BANGALORE DATED 29.7.2013

In exercise of the authority empowered in the clause 45(5) of the Rajiv Gandhi University of Health Sciences Act 1994, R R College of Pharmacy Bangalore is permitted to start Pharm D with an intake of 30 seats and Pharm D (PB) with an intake of 10 seats admission during the academic year 2012-13, subject to the following conditions.

1. To get increase in the seats of the proposed course only after obtaining the approval of the Pharmacy Council of India, the Rajiv Gandhi University of Health Science should accord final affiliation.
2. Regarding Affiliation; Permission of the Rajiv Gandhi University of Health Sciences should be obtained.
3. The Institution should follow the seats sharing of Government seats admission of existing terms.

4. Rules and Regulation, stipulated by Rajiv Gandhi University of Health Sciences and AICTE should be strictly followed.
5. Notice and order issued from time to time by the State Government should be followed.
6. There shall not be any kind of aid or financial assistance from the Government of Karnataka to this college. This comes under permanently un-Aided College.
7. 50% of the seats should be spared for approved Pharm D and Pharm D (PB) courses for the Government seats.
8. If any one of the above stipulated conditions of the Government is violation the affiliation / approval will be withdrawn.
